## **Woodland Referendum Approved By Voters**

According to Woodland Election Superintendent Cynthia Powell, voters approved the city's referendum in the Nov. 4 Municipal General Election and the state Special Election. Talbot County voters also voted for the Democratic candidates the Public Service Commission races.

#### **CITY OF WOODLAND**

The City of Woodland asked voters to vote yes or no on a referendum deciding if fluoride should be added to the city's water supply. According to Powell, the referendum passed by "the majority of voters."

There was no need for voters to cast a vote for mayor or council members, even though the names of the candidates appeared on the ballot.

Incumbent Mayor James Carter was the only candidate to qualify to seek the

Originally there were six candidates seeking the five council seats for the city. However, former council member Danny Barron, who originally qualified to seek a council seat, withdrew from the election on Sept. 25 leaving only four candidates for the four posts.

The five candidates who were elected include: incumbent T.L. Carter, incumbent John R. Haralson, incumbent Allison Owens, incumbent Jeffery Mitchell and newcomer Cynthia Carter.

## **CITY OF TALBOTTON**

There was no need for an election in the City of Talbotton since all the candidates who qualified were unopposed.

The following candidates will take office on Jan. 1.

**Incumbent Mayor Tony** Lamar will return to office. Timothy Turner will hold the Post 1 council seat; Annie Powell will hold the Post 2 seat; Andrew Hall will return to the Post 3 seat; Noddia Carreker will hold the Post 4 seat and Latasha Hollis will return to the Post 5 seat.

## **CITY OF GENEVA**

Likewise, the City of Geneva did not have to hold a municipal election.

Mayor Nigelco Marshall was the only candidate to

## As I Was Saying

I don't know about you, but I will be forever grateful to see 2025 in the rear-view mir-

This year has been, without a doubt, the lousiest year of my 67 on this little speck of dust in a sunbeam. While some areas of life have actually gotten better with age, one major area - my health - has started into a noticeable decline, and that decline is very disconcerting (to say the least).

You may have noticed that I haven't been around in these pages very much in the last few weeks. Well, I have been away. I know you're all weary of hearing about my health issues, but since I shared the story of the heart attack with you, I might as well bring things up to date.

But before I do, I want to give a shout-out to the publisher of this newspaper, John Kuykendall, who was forced to take on my responsibilities as well as his own during my illness. The fact that the papers got out on time and complete is a testament to how hard Johnny worked while I was away, and even though I'm back now (in a limited capacity for a time), he's still in there putting in yeoman's work to make these papers shine.

Thanks, Johnny.

Okay, back to the story on my health.

During the early days of recovery from the July 31 heart attack. I was prescribed more than a dozen medications to take each day. The fine physicians at WellStar hospitals in LaGrange and Marietta, who had me under their care, now believe one of them had an unexpected side effect which hit me pretty hard - a severe cough, one that lasted a long time and led to a lung problem that, to be honest, almost put me in the ground.

I won't name the medication (can't afford to face a lawsuit, you know) but it has this side effect that maybe 5% of users get. My dumb luck, I was in the five percent. And that side effect hit me like the proverbial ton of bricks.

The coughing was almost non-stop, and it became more and more difficult to breathe in between coughing jags. On October 8, I had a follow-up cardiology appointment in LaGrange, and I am very glad I kept it.

The cough had gotten so bad that I couldn't walk more than ten steps or so without stopping to wheeze myself back to something resembling normal. I have no doubt that the cough also annoyed everyone in every waiting room I sat in during those weeks. It got pretty wild around the office, too, as my colleagues listened to me trying to hack up a lung every ten minutes.

Anyway, when I went to the cardiologist, I was seated

in the waiting room (coughing, of course). They called me back, but the moment I entered the doorway the nurse "Sit ordered, down!" Apparently I was ash-grey and sweating, having trouble taking those steps. I did as I was told, and while I was with the cardiologist, the nurse was arranging an ambulance to take me to the hospital. "I can't let you go home like this," she

said apologetically. I would spend the next ten days at West Georgia Medical Center, initially being treated for fluid buildup around my heart - congestive heart failure, they call it. After ten days, the team decided I needed the specific care available at Kennestone Hospital Marietta, so I found myself there for the next fourteen

The heart issue began to ease as they took fluid off my body - and brother, did they take fluid off my body. I went into the hospital in LaGrange weighing 272 pounds, and on discharge I weighed 232. Yes, I lost 40 pounds in three weeks, all of it fluid. (I won't go into how that happened; it's icky and not fit for a family newspaper.)

But as the heart issue eased, the lung issue from the coughing took center stage, and we were back to square one as far as making me healthy again. Test after test, x-ray after x-ray, CT scan after CT scan, and the final diagnosis was something called Cryptologic Organizing Pneumonia.

That's a fancy term that means, "We don't know what causes it and we're not sure how to treat it, so we're going to try this." As it turns out "this" was the right thing to

After taking me off the medication that they suspected was the cough cause, the doctors began an intensive course of steroid treatments, and within a couple of days I was breathing better, my coughing had been reduced to nothing, and I was finally released from the hospital November 1.



## 2022 - Four U. of Idaho Students Murdered

Here is what happened this week in American History.

• Nov. 13. On this day in 2022, an event that could have been a Halloween horror movie takes place as four University of Idaho students are stabbed to death. Ethan Chapin, Kaylee Goncalves. Madison Morgen and Xana Kernodle were in a rented three-story house near the university, along with some other students. Between 4 and 4:25 am Christopher Kohberger entered the house and fatally stabbed all four. Other students in the house would discover the carnage and call police. During the investigation Moscow Police Department,

Federal Bureau Investigation found that a specific car had been captured on various surveillance camera systems and DNA evidence at the scene led to Bryan Christopher Kohberger, a PhD student in criminology and teaching assistant at Washington State University, a short drive from the murder scene. In a plea deal, Kohberger pled guilty to all charges but avoided the death penalty instead receiving four consecutive life sentences for the mur-

• Nov. 14. In 1910, aviation pioneer Eugene Burton Ely becomes the first pilot to fly an aircraft off a ship.

Curtiss pusher, visually similar to the Wright Flyer, and the cruiser Birmingham makeshift deck, served as the testbed. Two months later, Ely would land the aircraft on the cruiser USS Pennsylvania, proving that an aircraft could take off and land on a ship. Unrealized at the time, this was the beginning of the end of battleship dominance of the sea and the birth of seaborne air power.

• Nov. 15. Today in 1842, a slave revolt takes place that results in the deaths of at least 19. Whites were never the only ones to keep slaves and in this case it was various Native American Indian tribes. About 20

blacks escaped Cherokee Nation heading toward Mexico where slavery had been abolished. Raiding for supplies, they were joined by 15 slaves who had escaped from Creek Indians. They were pursued by Cherokee and Creek, with 14 either killed, or captured and returned to slavery. The remaining escaped slaves came upon two slave catchers who were taking slaves to the Choctaw Nation. The slave catchers were killed and the two slave groups joined, continuing toward Mexico. A combination of Cherokee and Choctaw Indians would capture some

of escaped slaves and five would be executed for the murders of the slave catchers. The remaining escaped slaves would be captured and returned to the various Native American Tribes.

• Nov. 16. In 1907, the Indian Territory and Oklahoma Territory are combined to form Oklahoma which becomes the 46th US

• Nov. 17. On this day in 1971, actor David Paul Ramsey is born in Detroit. Michigan. He has become an accomplished actor with roles in a number of televi-

Arrow, The Flash, and other DC-based superhero programs. He also portrayed boxer Muhammed Ali in *Ali*: An American Hero. Ramsey is 53 and still very active.

• Nov. 18. In 1950, the Korean War has taken a new turn and Chinese Commander Peng Dehuai has released over 100 prisoners-of-war, including 30 Americans. The POWs took back to South Korean, UN and US forces information concerning Chinese and North Korean shortages of food and ammunition, along with claims that Chinese troops were withdrawing back to China. It is just what South Korean, UN and US leaders wanted to hear and as a result overall Allied Commander Gen. Douglas MacArthur announced that American soldiers would be home by Christmas. Then ensuing drive against North Chinese Korean, Russian forces became known as the "Home by Christmas Offensive".

• Nov. 19. Today in 1493, long before America is a country, Spanish explorer Christopher Columbus first sights the island now known as Puerto Rico, which was claimed by Spain and colonized by Juan Ponce de Leon in 1508. Amerindian peoples were living on the island but quickly assimilated by arriving Spanish settlers. Puerto Rico became a US Territory in 1898, after the Spanish-American War.

## **Chinese Taikonauts Stranded in Space**

## Skywatcher in Hamilton Spots Fireball By ANDY KOBER

The more humans explore space, the more often incidents will happen.

It was reported last week that three Chinese taikonauts - the Chinese name for astronauts -- that have already spent six months in space, will have to stay a bit longer.

The taikonauts were scheduled to depart the Chinese space station, Tiangong, last Wednesday on board a Shenzhou-20 spacecraft but that was delayed due to the possibility the spacecraft suffered an impact with what has been called "space junk" or manmade debris in Earth orbit.

According to China's National Administration, the suspected impact was being analyzed along with a damage and risk assessment.

No further information has been released by the Chinese but there have been calls for Elon Musk and SpaceX to provide a rescue spacecraft to retrieve the taikonauts, much as SpaceX recently did for astronauts.

Our local amateur astronomer Ms Lynn, who is always a wealth of information, shared the Chinese name "Tiangong" translates to mean "Heavenly Palace".

It has been estimated that Leonids shower produced over 240,000 meteors in the space of about nine hours. It was such an astounding event the Cheyenne Indians established a peace treaty and the Lakota Indians were said to have reset their calendar. For some time afterward, the Native of birthdays Americans referenced the meteor storm. There were churches claiming that meteor storm was the beginning of the return of Jesus.

The meteor storm would become known as the Great Meteor Storm of 1833.

The current Leonids Meteor Shower will reach peak activity during the overnight hours of Nov. 16-17, but not with the fantastic display witnessed in 1833. Instead the typical number of meteors will be an average of 10 to 15 per hour, with the best viewing time from about 1 am to dawn.

The Leonids Meteor Shower is caused by dust and debris left by Comet 55P/ Tempel-Tuttle, which orbits around the Sun every 33 years. It was initially discovered by German astronomer Wilhelm Tempel on Dec. 19, 1865, and by American astronomer Horace Tuttle on Jan. 6, 1866.

This year the Moon should not be a factor with watching the Leonids Meteor Shower during peak activity.

**Keep your** eyes on the sky for passing fireballs. Meteors can flash across

the sky anytime and extraordinarily bright meteors are often referred to as fireballs --- and they are spotted quite

On Wednesday, Nov. 5, 127 people across Alabama, Florida, Georgia, Indiana, Kentucky, Missouri, Mississippi, North Carolina, South Carolina, Ohio, Tennessee and Virginia reported seeing a fireball. A person in Hamilton, GA also spotted that fireball.

The fireball was first reported at 6:56 pm Central Time by a skywatcher in Huntsville, AL. The fireball was seen as far north as Wapakoneta, OH, as far east as Bolton, NC; as far south as Edgewater, FL, and as far west as St. Louis, MO.

In Georgia, the fireball was seen as far north as Hiram, as far east and south as Savannah, and as far west as Hamilton.

None of the sky watchers reported hearing the fireball make noise as it passed but 23 people reported witnessing it fragment into smaller pieces. The fireball was caught on three videos and one still photo.

Anyone seeing a fireball is urged to report the sighting to https://amsmeteors.org Going outside and looking

at the sky, especially the night sky, can be fun and educational for the entire family.

There are a number of free apps available to help identify stars and constellations, and some of the apps will show satellites.

Pet Dingo? Why Not?

The state government in Queensland, Australia, is considering a classification change that would allow for dingoes to be kept as household pets.

The Queensland Department of Primary Industries is weighing a potential change that would see dingoes reclassified as Canis familiaris, also known as domestic dogs.

The change is being considered as part of a review of Queensland's biosecurity laws ahead of legislative amendments expected to be made in the spring.

Dingoes are currently classified as an invasive species in the state, meaning they cannot be released, relocated, fed, sold or kept. "Dingoes will continue to

be protected in national parks and landholders will still be able to take action to protect their livestock from wild dog or dingo attacks under the general biosecuobligation," Department of Primary Industries representative the Australian Broadcasting Corp.

The potential rule change has already received some push back from wildlife advocates experts.

"Dingoes are not dogs," Alix Livingstone of the nonprofit Defend the Wild wrote in her submission to a Department of Primary Industries discussion paper. "They are a genetically, evolutionarily, and behaviorally distinct species that play an irreplaceable ecological role as Australia's apex land predator."

Kylie Cairns, a genetics researcher specializing in dingoes, said the canines do not make suitable pets.

"They're more wild so they don't do as well in home environments as domestic dogs," she said. "They're much smarter, they're much better able to escape traditional domestic household home environments in terms of climbing up fences, and so they just don't generally fit into most domestic settings as easily."

Dingoes are currently legal to keep as pets in New South Wales and Western Australia, but rescue groups said many of the animals end up being abandoned or surrendered by their owners.


