### In Review: Top Stories of 2025

*Editor's Note: Below are some of the top stories reported by The Talbotton New Era during 2025. The are in date order.*

• The year began with a bang, literally. On Jan. 23 the newspaper reported the GBI was investigating a shooting incident that resulted in one person being killed and another person injured. The incident occurred on Wednesday, Jan. 15 at about 2:10 p.m. It was reported, the Talbot County Sheriff's Office requested the GBI to investigate a shooting. The preliminary investigation indicated that at about 2:10 p.m., the Talbot County Sheriff's Office was dispatched to a home on Tuck Person Highway in reference to a shooting. Upon arrival, deputies learned that Fazon Terry, age 29, of Woodland, and another man were involved in an argument that resulted in both men being shot. Terry was pronounced dead on the scene. The other man was taken by ambulance to a hospital in Columbus, where he was treated for injuries sustained during the shooting. To this day, it has not been reported if an arrested has been made in the case.

• On Jan. 30, this newspaper reported the Talbot County Board of Education and the Talbot County Board of Commissioners intended to opt out of Georgia House 581. After meeting and public hearings and the board's decisions to do so sparked controversy.

• On Feb. 6, the Talbot County Sheriff's Office arrested two teens after a shooting incident. The teens were charged with aggravated assault in connection with the shooting incident that occurred on Sunday, Jan. 5 around 1 p.m. inside the City Limits of Talbotton. According to Sheriff Bobby Gates, Jr. no one was injured in the incident. Arrested in connection to the incident were, Kendrevious Searcy, 18 and a 17 year-old juvenile both charged with aggravated assault.

• On Feb. 13, the newspaper reported former Talbot County Sheriff Justin "Jake" Johnson had been arrested by the GBI on charges connected with the arson fire at his Shiloh home that

occurred in Nov. 6, 2023. Johnson's home on Turkey Roost Lane in Shiloh, in Talbot County, burned and an investigation was launched by the Georgia Commissioner of Insurance and Fire Safety that led to charges being filed against Johnson and two Manchester men, identified as Jimmy Buchanan, 70, and Wallace Copeland, 62. All three were arrested by the GBI on Jan. 31. Johnson was charged with first-degree arson, conspiracy to commit a crime and insurance fraud. Buchanan and Copeland were charged with two counts of arson and one count of conspiracy to commit arson. All three were booked into the Harris County Jail following their arrests.

• On July 10, the Talbotton New Era reported the Columbus Police Department had made an arrest in the murder of Daryus Bryant, who was shot and killed in Columbus in April 2024. Zion Horton, 17, of Talbot County was taken into custody on Thursday, July 3 in Coweta County and transported to Columbus. Horton has been charged with murder, three counts of aggravated assault and possession of a firearm during the commission of a crime. Also, Semj Copeland, 18, also of Talbot County had turned himself in to authorities on July 8 and was charged with murder and three counts of aggravated assault. According to the Columbus Police Department at the time of the shooting, the incident took place at 11:50 p.m. near Macon Road and Lake Shore Road. According to reports, Police responded to a call of a shooting and on arrival discovered two cars which had been hit by bullets. Bryant was found to have been suffering from a gunshot wound. Also, Clarence Favors, of Manchester, was wounded in the incident. Bryant and Favors were transported to Piedmont Columbus

Regional, but Bryant did not survive the attack. Favors underwent surgery and survived. Bryant was a student athlete at Manchester High School and played football, basketball and was a state high jump champion and had received region and state honors for his athletic abilities. Both Horton and Copeland appeared in Muscogee County Recorder's Court on July 10. Copeland, Bryant's cousin, was a student-athlete at Central Elementary-High School. Copeland had been named All-Region Basketball Player of the Year for Region 6 and was named the Most Valuable Player of the Mid-South Madness All-Star game. Both Horton and Copeland pled not guilty to the charges during recorder's court.

• On Sept. 4, the New Era reported that Talbot County School Superintendent Dr. Jack Catrett had resigned after 13 years on Aug. 29. He had served as a superintendent for a period of 27 years overall and had been a teacher, principal, counselor and coach and served in education for a period of 44 years. Catrett said leaving the Talbot County School System was one of the hardest decision he has ever made.

• On Nov. 20, the newspaper reported the Talbot County Board of Education had named Jonathan A. Taylor as the new superintendent of the school system. The board began the search for a new superintendent when Dr. Jack Catrett resigned on Aug. 29. At the Nov. 10 meeting of the Board, Taylor was named the finalist for the superintendent's position. Taylor has served as principal of Central Elementary-High School for several years. Under Georgia law, Taylor was placed on a 14-day waiting period and on Dec. 11, the New Era reported that Taylor had signed his contract to serve as superintendent.

### CEHS Recognized as a CSI Progress School

Central Elementary-High School (CEHS) has been recognized by the Georgia Department of Education (GaDOE) as a 2025 Comprehensive Support and Improvement (CSI) Progress School, marking a significant milestone in the school's ongoing efforts to improve academic performance and student outcomes.

Each year, GaDOE identifies CSI schools that demonstrate measurable progress on their school improvement plans. To earn the CSI Progress School designation, schools must show at least a 5 percent increase in the College and Career Ready Performance Index (CCRPI) Content Mastery score from one year to the next and achieve a score of 80 or higher in at least one additional CCRPI compo-

nent—Progress, Closing Gaps, or Readiness.

In 2025, only 43 schools statewide met the criteria for recognition. CEHS was among those schools, reflecting meaningful academic gains and sustained improvement efforts across grade levels.

Georgia School Superintendent Richard Woods praised schools earning the designation, emphasizing the importance of collaboration and perseverance. "First and foremost, I want to celebrate the students, teachers, and staff who made these results possible," Woods said. "School improvement takes persistence, hard work, and a great deal of heart. These results remind us that when we work together and stay focused on students, real progress is possible in every corner of our state."

School leaders credit the recognition to intentional instructional strategies, data-driven decision-making, and the collective commitment of educators, students, families, and community partners. Focused efforts on strengthening classroom instruction, monitoring student progress, and addressing individual learning needs have contributed to CEHS's improved performance.

The CSI Progress School designation highlights CEHS's forward momentum and reinforces the school's dedication to continuous improvement and student success. Administrators note that while the recognition is an important achievement, the work continues as CEHS remains focused on providing high-quality learning opportunities for all students.

# Who is the only professional baseball player to have pitched two perfect games?

I am making two resolutions, one of which I shall immediately break. I resolve not to make resolutions; and I resolve to share trivia with you each week. Let's go!

*Did you know ...*  
... a poet tried a novel way to generate book sales? When Walt Whitman (1819-1892) wanted to stir sales for his collection *Leaves of Grass*, he sent in reviews for the book to the New York newspapers without a byline. His reviews (of his own work) called the book "transcendent" and proclaimed "An American bard at last!" Sadly, the reviews didn't help. *Leaves of Grass* sold only a few copies during its first print run. (Gives a new meaning to "reading one's own press releases," if you ask me.)  
... one of the oldest candies available has been around since the mid-19th Century? Love them or hate them, everyone who likes candy has an opinion about Necco Wafers™, flat round slabs of candy about the size of a quarter, which come in rolls of about 35. The candy was first produced in 1847 by the New England Confectionary Company, the initials of which incidentally form the candy's name. They are the oldest American candy brand still in production. *Additional trivia note:* The oldest continually produced candy brand is Good & Plenty™, the candy-covered licorice treat. Production of those began in 1893, but because of a break in production of Necco Wafers from 2018 to 2020, Good & Plenty are the oldest brand in continuous production. (And suddenly I want some candy.)  
... only one pitcher in all of professional baseball history has thrown two perfect games? A perfect game is one in which a pitcher retires all 27 opposing batters without allowing a single base runner. While the first perfect game in Major League Baseball was thrown in 1880 by Lee



Richmond (1857-1929), and the feat has been done only 23 times since then, no MLB pitcher has thrown more than one. The only professional ballplayer to throw two perfect games was Jean Faut (1925-2023), who pitched in the All-American Girls Professional Baseball League from 1946 to 1953. Faut, who played for the South Bend, Indiana Blue Sox, threw her first on July 21, 1951 against the Rockford Peaches, and did it again on September 3, 1953, against the Kalamazoo Lassies. *Additional trivia note:* Faut's two perfect games were two of only five pitched during the entire existence of the AAGPBL. The others were thrown by Annabelle Lee (1922-2008) of the Minneapolis Millerettes, Carolyn Morris (1925-1996) of the Rockford Peaches, and Doris Sams (1927-2012) of the Muskegon Lassies. The AAGPBL was featured in the hit 1992 movie, *A League of Their Own*.

... tropical storm classifications are based on wind speed? For a tropical storm to be considered a hurricane, its sustained winds must be at least 74 miles per hour. From 39 to 74 miles per hour, it's called a tropical storm, and with winds less than 38 miles per hour, it would be a tropical depression. (Thar she blows!)

... the design for a popular video game character was inspired by food? Toru Iwatani (born 1955), the game designer who created the popular "Pac Man" game, got the inspiration for the design of the title character from a pizza. Iwatani said he took a slice from a pizza and noticed how the remaining pie looked like a character, and used that as the design for the yellow dot-gobbler. ... a rock musician has a doctoral degree? Brian May (born 1947), guitarist for the group Queen, has an earned Ph.D. in astrophysics from Imperial College in London. (I've heard of spaced out, but this ...)

... noted author and political activist Helen Keller was

related to a Confederate general? Keller (1880-1968) was born in Tuscumbia, Alabama, and became deaf and blind at the age of two following an illness. She was related to Confederate general Robert E. Lee (1807-1870) on her mother's side. Keller's mother, Catherine Everett Adams Keller (1856-1921), was a second cousin of Lee.

... penguins sleep more deeply in the afternoon? ## Hobbies to Get Seniors Out and About

The threat posed by social isolation has been known to medical researchers and health care professionals for years, but the issue gained wider attention during the pandemic. Restrictions on social gatherings during the pandemic opened millions of people's eyes to the ill effects of social isolation, and while that threat proved temporary for the majority of people across the globe, many seniors continue to live largely isolated lives.

According to the Mayo Clinic, depression, anxiety, increased risk of suicide, and various chronic health problems are some of the outcomes associated with loneliness. That's a troubling assessment that becomes even more disconcerting when considering a general decline in socialization as evidenced by the 2021 American Perspectives Survey. Survey participants indicated they have fewer close friendships than they once did, speak with their friends less often and rely less on friends for personal support. That's challenging for adults of all ages, but it can be especially difficult for aging adults, who may be dealing with the loss of a spouse or other close confidantes they would otherwise rely on when confronting personal problems. Hobbies that promote socialization can help aging adults reestablish friendships and build new ones, paying dividends that can have a profound impact on their overall health. With that in mind, adults who feel as though their social circles are shrinking in mid-life or in retirement can look to these activities as means to rebuilding their social lives.

· **Book club:** A book club offers multiple benefits to adults. Book clubs are inherently social and tend to bring like-minded individuals together, which can help build new and lasting friendships that extend beyond weekly discussions. A 2021 study published in the journal *Neurology* also linked regular reading to a lower risk of developing dementia.

· **Sports:** Sports provide another avenue to socialize with like-minded individuals. Golf is not a team sport, but it is typically played in groups of two or four, making it an ideal activity for adults with free time on their hands to get out and about and meet other people. Leagues for softball, bowling and pickleball also provide opportunities to socialize, and many adults are participating in such leagues for that very reason. A CivicScience study released in 2025 found that 49 percent of adults who planned to participate in adult recreational sports leagues were doing so for social interaction and the chance to make friends.

· **Travel:** Travel can provide another means for aging adults to make friends. Group tours to foreign countries, day trips to local attractions arranged by township recreational offices or even overseas trips with friends you've fallen out of touch with can be a great means to build new friendships and reinvigorate old ones, all the while getting you out of the house.

These are just some ways for men and women to get out of the house and socialize with others their age, a worthy endeavor that can be highly beneficial to adults' overall health.

Wheelchair Bound Astronaut Takes Flight

Blue Origin scored a space first on Dec. 20, sending a wheelchair bound person into space. Aerospace engineer Michi Benthaus, along with five crewmates lifted off from the Blue Origin West Texas launch site onboard the New Shepard autonomous and reusable capsule. Benthaus, who works for the European Space Agency, has been bound to a wheelchair since a mountain-biking accident suffered in 2018. She was joined on the flight by aerospace engineer Hans Koenigsmann, investors Joey Hyde and Adonis Pouroulis, entrepreneur Neal Milch, and Jason Stansell. The New Shepard flights reach an altitude of 62 miles, which is recognized as the boundary of space, lasting 10 to 12 minutes from liftoff to touchdown. The Quarantids Meteor Shower is set to peak during the overnight hours of Jan. 2-3. This is a short-lived meteor shower that began on Dec. 28 and ends on Jan. 12.



There is a relatively short time period, only about six hours, during which to view the Quarantids at peak activity and the shower generally produces about 25 meteors per hour during peak. This year, the Moon will be nearly full and even with clear skies the light will wash out some meteors, however the Quarantids could produce some fireballs. That's a bummer and a sad way to end the meteor shower season. The next meteor shower will take place in April. Keep your eyes on the sky for passing fireballs. Meteors can flash across the sky anytime, day or night, and extraordinarily bright meteors are often referred to as fireballs — and they are spotted quite often. On Sunday, Dec. 14, 32 people across Alabama and Georgia reported seeing a fireball.

The fireball was first reported at 8:11 pm by a skywatcher in Okeechobee, FL. The fireball was seen as far north as Richmond Hill, GA; as far east as Pompano Beach, FL; and as far south as Cutler Bay, FL; and as far west as Tifton, GA. The fireball appeared to be traveling from north-north east to south-southwest. None of the sky watchers reported hearing the fireball make noise but six people reported seeing it fragment into pieces. Anyone seeing a fireball is urged to report the sighting to <https://amsmeteors.org>. Going outside and looking at the sky, especially the night sky, can be fun and educational for the entire family. There are a number of free apps available to help identify stars and constellations, and some of the apps will show satellites. Happy skywatching!
